I Litan Biswas, R/O: Nitai Biswas, R/O: Pulkari,
West Dhamtala, ^{PS-NAP} Jalpaiguri, would like to state the
following facts:

1. That, I along with my fellow friends was attending
a "MAGS Marriage Ceremony" organised by "Vanvazi
Kalyan Ashram, Uttarbanig" today at around 2 pm.

That while the ceremony was going on, I
along with my friends observed that few minor boys
and girls were indulged in intimate and
objectionable photography near the place of
occassion. When we asked them not to do
such obscene act openly, they started filthy
argument with me and my fellow members.

3. That when I asked their names and
addresses, they shouted their names with threats.
The names were Hindan namo prima facie.
But when we pressurised them to reveal
their original identity, they said their names
were, Md Rinky, Md Manjoor, Md Chand, Md
Sajjad Hussain, Md Azad, Md Tiyaku and

4. That after revealing their true identity they started abusing me and called their friends roaming around. Instantly 35 to 40 people gathered with fatal weapons like rods, sticks, bamboos, chains etc to attack us. When I tried to capture the incident, they snatched my mobile and threw it away and started thrashing me with fist and blow and with rod, stick and chains. They were angrily shouting "Sobai miley maagire Felai Dum" (lets kill him). I was badly beaten and have received injuries in my head, face, eyes, chest, back and neck. I was choked and my neck was strangled with an intent to kill me. My friends rescued me from the hands of this anti social elements who attacked me with an intent to kill me.

5. That even after my rescue, me and my friends were continuously threatened that ~~we~~ we will be killed if we report to police or pursue the case.

6. That I humbly request you to take strict and prompt action against this criminals and pursue the case after arrest of the same. For this act of justice I shall ever be indebted to you.

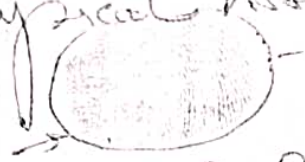
