Darjeeling beg to inform you that on Dt. 05/05/2022 at about 01.30 am, when I was present at our house at Santoshi Nagar, noted above at that time, my brother namely (1) Sanjay Gupta S/o Sri Radheshyam Gupta & his sons namely (2) Raju Gupta & Rajesh Gupta, both sons of Sri Sanjay Gupta, all are resident of Santoshinagar at above noted address, started abusing my father namely, Sri Radheshyam Gupta S/o Lt. Jemune Prasad Gupta, my mother namely, Smt. Rajkumari Gupta w/o Sri Radheshyam Gupta, both are of above noted address, and whom we alongwith my brother namely, Sameer Gupta S/o Sri Radheshyam Gupta, protested, they started beating us brutally with Botam (wooden log), and me, my parents & my brother, some Gupta received severe injury to ^{our} ~~the~~ persons, and they stolen away, Gold chain of my brother Sameer Gupta from his neck.

Sir, me, my father & brother Sameer Gupta, immediately shifted to Siliguri Distt. Hospital and treated ourselves there,

Sir, my said brother Sanjay Gupta & his (two) sons noted above are very desperate & dangerous in nature and they have threatened us for dire consequences.

So, please take necessary action against (1) Sanjay Gupta S/o Sri Radheshyam Gupta (2) Raju Gupta & (3) Rajesh Gupta, both are sons of Sri Sanjay Gupta, all are of Near Khatu Shyam Mandir, Santoshi Nagar, Ward No.5 SMC, P.O. P.S. Siliguri, Distt. Darjeeling.
