I, Atish Dutta Chowdhury, son of Late Ahindra Dutta Chowdhury, aged about 38 years working for gain as Branch Operation Officer of Ujjivan Small Finance Bank Ltd, having its branch office at Ground Floor, Ujjivan Small Finance Bank, Kelson Complex, Sevoke Road 'Siliguri, West Bengal, 734001, do hereby intimate as follows: -

This is to inform you that same theft incident has taken place at outside of the premises of Ujjivan Small Finance Bank Limited, Siliguri Branch which is previously occurred on dated 10-05-2021, Again on 07-05-2022 some unknown miscreant have stolen copper wire cable from the outdoor AC vent installed for Branch at our Siliguri Branch . The rear side of the building was not under CCTV camera and it came to light when housekeeping Staff Pralay Deb informed while checking the reason for not working of AC . It was that notice that the copper wire pipe from the AC have been removed by some unknown miscreants .

As a consequence, the AC of the lobby is not working, Requesting you to kindly look into the matter and take necessary action as per law.
