Sir,

I, Sri Anup Kumar Das @ Babul, Son of Late Anil Chandra Das, resident of Goala patti, ward No.4 of S.M.C., P.O. & P.S. Siliguri, District- Darjeeling, lodging this complaint against one Md. Kalu, son of Late Tafiluddin @ kafiluddin, resident of Goala patti, ward No.4 of S.M.C., P.O. & P.S. Siliguri, District- Darjeeling. On 07/05/2021 at about 10.30 am in the morning when I was In my house. I saw Julekha Khatoon (mother of Kalu), Daughter (Nick Name Bunu) of Kalu throwing litter of their house in my house. When I protest against their such work Md. Kalu suddenly attack the door of my house with "Shabol". But my front door is made by Iron Sheet that's why he cannot able to break the door. Then he suddenly went to their roof top which is very much adjoining to our boundary. That time I went out from my room and he throw a piece of break by targeting me that I can injure severely. But unfortunately that brick injured my right leg.

In this contest I inform you on 23.04.2019 that Md. Kalu Son of Late Tafiluddin @ kafiluddin attacked me in some manner that time brick hit my head and I was very much injured and Hospitalized. On that context lodged a complaint at Siliguri P.S by my brother Ashish Das, Advocate, Vide Slg P.S Case No-258/2019 under Section 307 of I.P.C

That Md. Kalu his mother and daughter usually provoked me and my family by throwing many illegal things and used woman wastes in our premises.

Today Md. Kalu also threatened me and Loudly Shouted that "Sala Toke Mere Felbo" with many filthy words.

Now today I also injured very much and treated by Siliguri Sadar Hospital.

I, therefore, humbly submit to kindly investigate the matter with immediate effect and to take appropriate legal action against the culprit and to punish him in accordance with law.
