Shabdar who are residents of near Ashraful Masjid, Ashraf Nagar, Ward No. 40 S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri called upon my son Md. Raju to her residence.
2. That the above mentioned Miss Meher has a love and affairs relation with a boy namely Md. Abdul Kalam, S/o Bhondo residing at near Ashraful Masjid, Ashraf Nagar, Ward No. 40 S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri.
3. That above mentioned Abdul Kalam is friend of my son and thereby my son is familiar to both of them.
4. That since last few days there is a dispute has been cropped up between the above named Miss Meher and Abdul Kalam and as my son is a friend of Abdul Kalam the above Miss

Meher called my son to solve their personal problem and when my son said that he has nothing to do with their personal problems the said girl along with her other sisters assaulted my son very badly by fists and blows.

5. That my son came to my house and disclosed the fact to me and soon after the incident 1)Md. Chhotu, S/o Tailor Master along with his father 2)Tailor Master, S/o unknown 3) Md. Saiyab@ Shaoib, S/o unkonwn 4) Md. Shabdar, S/o unknown, 5)Md. Shahrukh, S/o Md Shabdar, 6) Roshni, D/o Md. Shabdar, 7) Chanu, D/o Md. Shabdar, 8) Mcher, D/o Md. Shabdar, 9) Shahnaz, W/o Shabdar all are residents of near Ashraful Masjid, Ashraf Nagar, Ward No. 40 S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri came to my house and physically assaulted me and my son very badly with fists and blow and the all male persons touched my private parts and assaulted on my private parts also by kick and blows and I sustained severe injuries on my private parts also and Md. Shabdar brought stone and attacked on my forehead and the group were continuously shouting to set fire at my house and they threatened to kill me and my son before the public and the neighbours came and rescued us from their clutches and they fled away.
6. That again on 07:00 PM they all came to my resident and assaulted me and my son badly and meanwhile Md. Shabdar pressed my throat and tried to strangulate for killing me but


