**Sub:- LODGING OF FIR AGAINST UNKNOWN CIVIL PERSON/DRIVER
REGARDING ACCIDENT OF BSF VEHICLE NO- WB-74BA-1086 M&M
BOLERO SLF POWER+.**

Sir,

It is submitted that I No 063994458 Constable/Driver Mahadik Amol presently serving in STC (Subsidiary training center) Border security Force, Baikunthpur, Salugara.

2. On dated 06 May 2022, I was detailed as driver along with vehicle guard on Vehicle No **WB74BA-1086 M& M BOLERO, SLF POWER+** for Govt duty from Subsidiary Training Centre, Baikunthpur, to NJP Railway station for conveyance of troops. While moving toward Siliguri, at about 2230 Hrs a high speed civil Medium truck coming from Siliguri (opposite side) suddenly overtook the another vehicle moving in front of it, in that process the civil truck came directly in front of my vehicle and hit the front right side of the vehicle No- **WB74BA-1086, BOLERO**, near Delhi Dhaba, Salugara more (Tri Junction) on NH 10, however, speed of Govt. vehicle had already slowed down by me due to which relatively lesser damage was occurred in the BSF Veh. There is no casualty occurred during this incident. Following damage occurred in BSF vehicle due to this:-

1	Front right side head light damage.
2	Wind screen & Wind screen frame right side damaged.
3	Right side door bend/damage

3 Keeping in view of above it requested to lodge FIR against unknown civil driver and take appropriate action against culprits.
