I, Ratan Ghosh, son of Late Dulal Ghosh, resident of Khola Chand Fapri, Baikunthapur, Post Office: Salugara, Police Station: Bhaktinagar, District: Jalpaiguri, want to inform you that I am the owner of "UTSHO HOTEL" (Restaurant, Bar and Foreign – Liquor Off – Shop) at Eastern – By – Bass under your jurisdiction.

That on 08/05/2022 at about 10 P.M. to 10:30 P.M. one **Sukhdev Rudra**, son of not known, resident of Shibram Pally, S.M.C. Ward No. 39, Police Station: Bhaktinagar, District: Jalpaiguri, came to my Foreign – Liquor Off – Shop and asked my staff to give him some liquor brand and one of my staffs gave the same and asked him for money, but said **Sukhdev** denied to give the same and told that he is the biggest "LAND – MAFIA & MASTAN" of the area and he will not give the price of the liquor which he purchased and started to abuse my staffs of my Bar and Foreign – Liquor Off – Shop.

That hearing some chaos I went to the said spot and tried to restrain said **Sukhdev Rudra** but seeing me he just may be some unknown reasons he took a "RAAM DA" from his vehicle and tried to murder me with the same, but somehow I managed to escape without any injury or hurt.

That after that when I left the spot said **Sukhdev Rudra** not only stopped there but after that he charged with his said "RAAM DA" to my live kitchen and to intend to murder me he also attacked my office.

Under the above circumstances it is my humble request before you to investigate the said matter and to take appropriate penal sections against **Sukhdev Rudra**, son of not known, resident of Shibram Pally, S.M.C. Ward No. 39, Police Station: Bhaktinagar, District: Jalpaiguri as he tried to murder me but somehow I have escaped.
