
In producing herewith one accused person namely Prakash Mahato (22/M) S/O Late Lakhan Mahato of Santoshi nagar, Chandni Chowk, Ward No.05,PS- Siliguri, Dist- Darjeeling along with 14(fourteen) bottles of Himalaya Gold 60up Country spirit each bottles containing 600 ml. & MRP Rs 120/- each bottle Total RS.1680/-

I ASI Sanjay Hasda of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 09.05.2022 at 20:25 hrs. received an information from Santoshi Nagar, W/NO-05, PS- Siliguri, Dist- Darjeeling that one person has gathered huge quantity of illegal liquor which kept in his house for selling the same in the open market for his wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO - 178 Dated-09.05.2022. As per your kind instruction myself along with ASI Kalachand Singha, C/239 Badal Barma C/390 Sujit Paul and proceeded to the PO to work out the information. At 20:40 hrs. we reached at the Shantoshi Nagar, W/NO-05 sometimes after being identified by the source our police party held raid and recovered the above noted articles from the possession of above referred person. On demand he could not produced any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell same in open market for his wrong full gain. In presence of witnesses I seized the above noted articles from her possession after prepared proper seizer list and level and took signature of the accused person one bottles taken as sample .The seizure was made in between 20:50 hrs. to 21:35hrs. I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Prakash Mahato (22/M) S/O Late Lakhan Mahato of Santoshinagar, Chandni Chowk, Ward No.05,PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for investigation .
