Respected Sir, I, MD. ABU KASHIM, S/O MD. SAFIUDDIN, R/O Chow  
pukuria Malal, Bagdogra, Dist-Darjeeling, 734014 would beg  
to inform you that on 7<sup>th</sup> May 2022 around 5:45 P.M. a  
person named MD. Jumar, <sup>R/O Halal Basti</sup> hit my daughter with his bike  
outside  
our residence (Halal Basti) and he fled the scene as  
soon as he realised that he hit my daughter. My daughter  
FARA PARBIN has been badly injured, her right <sup>leg</sup> is broken  
and she being a minor is facing lots of problem. The said  
person who was riding the bike was over speeding and he doesn't  
hold a proper driver license and doesn't even have any kinds  
of document for his bike. Upon confiscating him he denied to  
pay any kind of expense for my daughter's treatment. He doesn't  
show any kind of remorse for his action and we are filing  
this F.I.R to meet the end of Justice.
