Sir,

I, ASI Jakirul Islam of Bagdogra P.S. Siliguri Police Commissionerate, do hereby lodge this written complaint against the following arrested persons 1. Ramji Sha (32y) S/O Lt. Narayan Sha of Airport more, Maszidpara ps. Bagdogra Dist. Darjeeling 2. Sunil Roy (22y) S/O Lt. Ramu Roy of Tigerbusty ps. Bagdogra Dist. Darjeeling 3. Md. Soukat (22y) S/O Md. Muslim of Tigerbusty Ps. Bagdogra Dist. Darjeeling 4. Dipankar Barui @ Somnath (29y) S/O Samir Barui of Khudirampally ps. Bagdogra Dist. Darjeeling under arrest along with following articles; (i) One (01) Iron made Hasua but made in wooden (Sharp cutting weapons) measuring approx length 15 inch width 3 cm wooden butt 16 cm and one torch light recovered from the possession of Ramji Sha which was kept on his right hand (ii) One 16 mm iron rod length approx 44 inch (seems to be implement of lock breaking) recovered from the possession of Sunil Roy (iii) One iron made hand Dao (Sharp Cutting weapon) measuring approx length 15 cm including butt width 6 cm recovered from the possession of Md. Soukat (iv) One iron knife plastic handle (Sharp Cutting weapon) measuring approx length 12 inch including plastic butt width 3.5 cm and one big size plastic gunny bag inside the gunny bag one nylon rope recovered from the possession of Dipankar Barui @ Somnath which he was holding on his hand.

In this regard, I beg to report that on 10.05.22 at 20.45 hrs received secret reliable source information that about 8/9 anti socials armed with deadly weapons assembled at NH-31 high road just crossing the Khanna Hotel area making preparation to commit Dacoity at adjacent of Bagdogra PS, area. I shared the information to OC Bagdogra PS, in hand and diarized the fact vide Bagdogra PS GDE No. 427 Dated 10.05.22. and as per direction of OC Bagdogra PS, at 20.50 hrs, I along with C/1008 Kanak Roy, VP/01 Ansalam Kujur, CV/375 Jogesh Barman CV, 386 Kishor Ranjan Hawlader left for near Khanna Hotel area work out the information vide Bagdogra PS GDE No. 428 Dtd. 10.05.22 during the time of departure all officer and force had brief properly also bring with required papers / articles if necessary. At around 21.20 hrs we reached at NH-31 high road near Khanna Hotel area and kept our vehicle in a considerable distance also called the K-36 evening van party. Then, I along force with K-36 evening van Officers and force headed towards Khanna Hotel area after crossing the Khanna hotel looking for witnesses, if any on the way and found that due to night none persons seen at that time on that area in faint light of street lights on the south side of road corner, we could see a group of persons standing and were whispering in subdued suspicious manner beside the NH-31 road. On seeing us, they tried to flee away but somehow a hot chase the above noted four persons could be apprehended and detained. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with 4/5 others their associates assembled at the spot making preparation to commit road Dacoity tonight by outgoing of Kolkata and Bihar bound passengers bus's. I accordingly searched them and found (i) One (01) Iron made Hausa but made in wooden (Sharp cutting weapons) measuring approx length 15 inch width 3 cm wooden butt 16 cm and one torch light recovered from the possession of Ramji Sha which was kept on his right hand (ii) One 16 mm iron rod length approx 44 inch (seems to be implement of lock breaking) recovered from the possession of Sunil Roy (iii) One iron made hand Dao (Sharp Cutting weapon) measuring approx length 15 cm including butt width 6 cm recovered from the possession of Md. Soukat

(iv) One iron knife plastic handle (Sharp Cutting weapon) measuring approx length 12 inch including plastic butt width 3.5 cm and one big size plastic gunny bag inside the gunny bag one nylon rope recovered from the possession of Dipankar Barui @ Somnath which he was holding on his hand and 4/5 others managed to escape from the spot. Accordingly, I seized above noted articles under proper seizure list duly signed by them and arrested them u/s 41 CrPC informing them their ground of arrest preparing memo of arrest: The seizure was made in between 21.35 Hrs to 22.45 Hrs of dated 10.05.22.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit a road dacoity at National High Way road. Further, it is to mention here that the arrested accused persons are well known anti socials and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against them and 4/5 others who fled away under proper section of law and to cause its investigation.
