With due respect I the undersigned would like to inform you that, I have lodged a written complaint on 31/08/2020 to you (Xerox copy of the complaint dated 31/08/2020 is annexed herewith for your kind perusal).

I would like to further inform you that my wife Smt. Sanchita Sarkar has entered into second marriage with one Bapi Saha, S/o Late Birendra Kumar Saha and on 31/08/2020 at about 08:30 p.m. they have been caught in red hand in the house of said Bapi Saha at South Colony Bazar, P.S. - NJP, Dist. -Jalpaiguri by the local people in that area and the matter was informed to you and one ASI Khela Murmu reached there and in presence of all the people, my wife and said Bapi Saha narrated that they have entered into the marriage on 01/06/2020 and they are residing there as husband and wife and ultimately they have been caught by the said police personnel and brought them in the police station at about 10:30 p.m. on that day (the entire incident has been recorded in mobile). Thereafter I have lodged a written complaint at about 11:00 p.m. on that day and the duty officer received the same on that day but he requested me to come on the next day morning for the case reference and I went to the police station at about 11'0 clock and my complaint was endorsed as general diary being NJP P.S. G.D. Entry No. 15/2020, Dated 01/09/2020 and the concerned duty officer informed me that my wife and her second husband have been forwarded to Jalpaiguri Court but denied to give any case reference of my complaint.

I would like to further inform you that thereafter I searched in the Jalpaiguri court regarding the case reference and I found that my wife and said Bapi Saha have been forwarded to Ld. C.J.M. Jalpaiguri in connection with NJP G.D. Entry No. 18 / 2020, Dated 01/09/2020, U/S - 290 of I.P.C. but no specific case has been registered in respect of my said complaint dated 31/08/2020 and I was compelled to file a writ petition before the Hon'ble Calcutta High Court circuit bench at Jalpaiguri being WPA No. 8988/2020 against the said police in action and after filing the said Writ petition, a case has been started being NJP P.S. Case No. 1309/2020 dated 04/11/2020 U/S -
