Respected Sir,

With due respect I Sandip Bhadra residing at 54/55, Deshopriya Sarani, Bhaktinagar West, Ward No. 34 (SMC), PO - Bhaktinagar, Dist. - Jalpaiguri, Pin No. 734007 like to inform you that my son Master Bhargav Bhadra is presently studying at Don Bosco School, Siliguri.

Last Friday i.e. on 29.03.2022 in between 15.15 hrs and 15.40 hrs while he was returning home from the school by it's School Bus No. 06 and bearing Registration No. WB-73-D-0851 and he was trying to cross the street at Central Bank More, in front of Agrani Sangha Club situated at Ward No. 35 (SMC), an unknown small auto (Black and yellow coloured) suddenly thrashed him and fled away. Resultantly, my son got injury on his person.

Then we rushed to the Siliguri District Hospital (emergency ward) and consulted with the on duty doctor (Copy of receipt enclosed). He recommended for an x-ray (Copy of receipt enclosed) and advised to further consult with an Orthopedic. On the very next day i.e. on 30.03.2022 we take him to the hospital and do the same as instructed.

But due to my engagement in official work at LIU, Siliguri PC under IB, North Bengal Wing, Siliguri, I couldn't lodge complaint immediately after the incident. But this is my earnest request to you to take needful action so that the culprit can be brought behind bars.
