In producing herewith two [02] arrested accused namely 1. Asem Sk. [26] S/O Jalal Sk. of Sannyashi, P.O. Talgachhi, P.S. Murshidabad, Dist. Murshidabad (not verified) and 2. Juel Sk. (27) S/O Sir. Sahidul Sk. of Hariharpara, P.O+P.S. Hariharpara, Dist. Murshidabad (not verified) along with the following articles under seizure as per seizure list:

i) One packet containing 22.5 Kgs of "Ganja" wrapped with brown colour cello-tape being kept inside a bag - seized from the possession of above noted Asem Sk. and marked as Exhibit-A',

ii) One packet containing 25 Kgs of "Ganja" wrapped with brown colour cello-tape being kept inside a bag seized from the possession of above noted Juel Sk. and marked as 'Exhibit-B',

I, SI Newton Biswas, S/O- Nirmal Biswas of New Jalpaiguri Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted accused persons to the effect that on 06 05.2022 at about 20.25 hrs I received a specific source input that two persons were standing near Auto stand, NJP Railway Station under New Jalpaiguri Police Station with huge quantity of Ganja for delivering the same to his designed customers. The matter was diarized in New Jalpaiguri PS GDE No. 289 Dt- 06.05 2022 and also informing the matter to the Officer-In- Charge, New Jalpaiguri Police Station in written and being directed, I along with ASI Sajal Das, HG/794 Ranjit Roy, VP /08 Laxman Roy, VP/ 13 Jaminul Islam and CV/ 116 Robit Kumar Mahato all belongs to New Jalpaiguri Police Station left for Auto Stand, NJP Railway station under PS- NJP by Govt. vehicle to verify the veracity of the information vide New Jalpaiguri PS M.C C. NO. 1310 Dt. 06.05.2022.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

At the time of departure from Police Station I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc.

On way to near Auto stand, NJP Railway Station under New Jalpaiguri Police Station, I contacted two persons namely (i) Bindubashi Das @ Tinku S/O Biswanath Das of Kathal Tolagali, Bhaktinagar, P.S-New Jalpaiguri Police Station, Dist.- Jalpaiguri and (ii) Rubel Haque (24) S/O Taiyab Ali of Atiyabari Part No. II, P.S. Sahebganj, Dist. Coach Behar A/P staff of Mampi hotel, P.S. NJP, Dist. Jalpaiguri make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter we along with the independent witnesses reached near Auto stand, NJP Railway Station under New Jalpaiguri Police Station at 20.55 hrs and being pointed by my reliable source approached towards two accused persons standing there, each of them carrying one bag. At that time seeing the Police party approaching towards them, they started fled away from the spot but, however we managed to apprehend them with bag under conscious and exclusive possession of above noted Asem Sk. and Juel Sk.

Thereafter, we disclosed our identity and the information in hand and stated that they will be searched in person for the purpose. At this, they after disclosing their identity as noted above admitted that they have illegally possessed ganja in their possession for selling the same to their designed customers as per requirement. I then gave them option in writing whether they wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. Then they agreed to be searched in presence of any one of the above, I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party.
