Sir,

Most humbly I the undersigned apprising you that Kekaru Hajra, S/O. Late Bhanda Hajra, resident of Champat Gachh, P.O. Fulbarihat, P.S.NJP, Dist. Jalpaiguri was my uncle, and he had no issue, the uncle of my wife namely Bhadri Hajra expired prior to the death of my uncle, and after demise of my uncle the schedule land and also the other land devolved upon my father namely Saltu Hajra (Das) as per Hindu Succession Act and after demise of my father the schedule property devolved upon me and my brothers, sisters and upon my mother as per Hindu Succession Act.

I further apprising you that the person mentioned in the bottom of the FIR was born at Lakhipur, P.O. Patiram, P.S. Balurghat, Dist. Dakshin Dinajpur, Pin- 733133 and his father's name was Tepe Das and mother's name is Genota Das.

I further apprising you that Bablu Das, Mohan Das, Kartik Das, Sambhu Das and Jyotsna Das are the brothers and sister of the person mentioned in the bottom of the FIR i.e. Sambhu Das.

I further apprising you that the person mentioned in the bottom of the FIR makes false documents like Voter I/D Card being No. WB/03/021/501690, Ration Card, Aadhar Card and in the said documents he is claiming himself as a son of Kekaru Hajra and put the name of Kekaru Harja/Kekaru Das as his father and on the basis of the said forged documents he is claiming the son of my uncle Kekaru Hajra, and he is in connivance with the BL&LRO, Rajganj, recorded his name in the land left by my uncle Kekaru Hajra, who had no issue vide LR Khatian No. 644, J.L. No. 3, Mouza- Binnaguri i.e. the land mentioned in the schedule hereunder and on the basis of the said documents Sambhu Das is claiming title of the schedule land on the basis of the forged documents and thereby committed an offence a forgery and cheating.
