P.O. - Siliguri Bazar, P.S. - Siliguri, District - Darjeeling, PIN - 734005, West Bengal, would like to bring to your kind information the following facts for consideration.

2. That this is to inform you that I, the undersigned, along with Sri Pankaj Kumar Mittal, Sri Ashutosh Bansal, Smt. Rinku Bansal, Sri Rajendra Prasad Agarwala, Smt. Rewati Devi Agarwala and Smt. Pisto Devi Agarwala by virtue of the four separate Sale Deeds, being Document Nos. 4020, 4019, 4022 and 4018, all for the year 2020 and registered in the office of the Additional District Sub-Registrar, Bhaktinagar, collectively became the absolute and exclusive owners in possession of all that land in total measuring 0.61 Acres, having permanent, heritable and transferable right, title and interest therein and the said land was recorded in our names in the L.R. record of rights, in L.R. Khatian Nos. 2135, 2131, 2124, 2123, 2134, 2130 and 2125 respectively, forming part of R.S. Plot No.70 corresponding to L.R. Plot No.114, situated within Mouza - Binnaguri, J.L.
