Respected Sir,

I, Manju Devi Kundalia, W/o Sri Surajmal Kundalia, resident of S.F. Road, Siliguri - 734005, P.O. & P.S. Siliguri, District- Darjeeling, do hereby inform you as follows:

1. That I am the owner in possession of land measuring 10 Kathas and 40 Sq. Ft. appertaining to and forming part of R.S. Plot No 70 recorded in Khatian No. 2724 of Mouza - Binnaguri, Sheet No. 18, morefully described in schedule below by virtue of 3 Deeds of Conveyance being Document No. 2032, 2033, 2628 all for the year 2001 registered at the office of A.D.S.R Jalpaiguri.
2. That thereafter I mutated the land and the concerned department issued a Khatian in my favour vide L.R Khatian No. 1005.
3. That in order to safeguard my land I constructed a boundary wall on the land and install a gate, however for the past few days some persons namely 1. Amirul Islam, S/o Late Ojibar Rehman, resident of Paschim Balabari, 2. Amarul Islam, S/o Late Ojibar Rehman, resident of Paschim Balabari, 3. Mofita Begum, W/o Abdul Khalek, resident of Bhurgivita 4. Arjuara Begum, W/o Wased Ali, 5. Ayub Ali 6. Anowar Ali both are sons of Wazed Ali, residents of Paschim Dhantala, and 7. Anjuara Begum W/o Ajahar Ali, resident of Nakugach, P.S. Rajganj in the District of Jalpaiguri alongwith some other men and their associates have been trying to enter my said land in multiple ways.
4. That around 15 days back these persons tried to enter into my land by jumping over the boundary wall but due to the resistance from local people they failed to do so.
5. That around a week ago, they again reached my land and tried to enter the land however on getting the information my relatives reached the spot and they fled away.
6. That yesterday at around 2 p.m. I got information from the local residents that they have already broke down the lock on the gate of my land and may take forceful possession of the land at any time and on getting the information, I along with my
