Respected Sir,

This is to inform you that on 7th May, 2022, at
 around 7:40pm, my father late Bimal Chowdhury residing at
 Purba Dhanatala, P.O. - Satellite township, P.S. - NSP P.S., Dist. -
 Jalpaiguri, WB - 734015 was crossing the road i.e. Asian
 Highway - 02 near Canal More was hit by Mr. Nitesh Subba
 s/o Sunny Subba who was rashly driving bike model Pulsar 200 NS
 Black with stickers all over and hit my father Bimal
 Chowdhury. Mr. Nitesh Subba was in rush and in high speed
 neglecting all traffic rules.

As a result, my father sustained severe head injuries &
 severe leg fracture and serious blood loss. He was taken imme-
 diately to Maharaja Agrasen Hospital, Fulbari Bypass, as there
 was no neuro-surgeon available, we had to take my
 father to North Bengal Medical College as advised by them.
 After arriving at NBMCH, my father was declared Brought
 Dead.

In the above context, this is to inform you that NSP
 P.S. officials arrived at the accident spot & taken the bike
 bearing regn. no. WB-72U-9013 & Mr. Nitesh Subba to police
 station. This is submitted for necessary legal actions against
 the bike driver.
