Sir,

I, Sri Arun Roy, Son of Late Ashit Roy, resident of Sukanta Sarani, Milanpally, Post Office & Police Station – Siliguri, District – Darjeeling, Pin – 734005, beg to lodge this complaint as under :

1. I along with my wife, Smt. Kakoli Roy, in the year 2016 purchased the land measuring altogether 16(Sixteen) Katha 8(Eight) Chhatak or more or less 0.28 Acre in part of R.S.Plot No.578/1551 corresponding to L.R.Plot No.8 in R.S.Sheet No.15 corresponding to L.R.Sheet No.182 at Mouza - Dabgram, within Ward No.32 of Siliguri Municipal Corporation, Police Station – N.J.P. (formerly at Bhaktinagar), District – Jalpaiguri, by virtue of 4(four) registered Deeds of Conveyance being Nos.1-565, 1-566, 1-567 and 1-1656 all for the year 2016.

2. After the above purchase, we started using, enjoying and occupying our aforesaid land measuring 16(Sixteen) Katha 8(Eight) Chhatak or more or less 0.28 Acre, constructing boundary walls in and around the said land.

3. In the meantime, considering the title and possession of the said land, our names have been recorded in L.R.Khatian being Nos.31 and 32 in part of L.R.Plot No.8 in L.R.Sheet No.182 at Mouza – Dabgram, Police Station – Bhaktinagar (presently at N.J.P.), District – Jalpaiguri.

Suddenly in the month of August 2020, one Wazed Ali Sheikh, Son of Late Helaluddin Sheikh, resident of Meghlal Saha Sarani, Haiderpara, Siliguri, Police Station – Bhaktinagar, District – Jalpaiguri and his associates viz. (i) Sri Santu Debnath, Son of Sri Nirmal Debnath, resident of Bagha Jatin Colony Main Road (Opposite to Margaret School Lane), Pradhan Nagar, Siliguri, (ii) Sri Badal Dey, Son of Sri Gopal Dey, resident of Road No.6, Saktigarh, Siliguri
