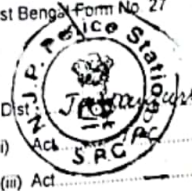

Sub: Complaint

With due respect, I, Ashok Agarwal, Son of Late Labh Chand Agarwal, resident of Nanda Apartment, Near Children Park, Milan Pally, Post Office Siliguri Bazar, Police Station : Siliguri, District : Darjeeling [West Bengal], like to state that I am the absolute owner in possession of a plot of land measuring 0.36 Acres, appertaining to Plot No. 448 as recorded in Khatian No. 64 of Mouza Jugivita, PS. Ambari -Falakata TOP under NJP Police Station [Previously Bhakti Nagar Police Station], District : Jalpaiguri [West Bengal], which I purchased for valuable consideration by virtue of a Deed of Conveyance which executed by one Sri Rana Bose Son of Late Ambareswar Bose of Deshbandhu Para, Siliguri, by virtue of a Deed of Conveyance executed on 18th November, 1992 and registered at the office of the then 2nd Sadar Joint Sub Registrar, Jalpaiguri at Rajganj, in Book No. I, being Deed No. 4246 for the year 1992. It is stated that at the time of purchasing the said plots of land, I had/have arranged to demarcate the said land by pucca demarcation in all sides of the said plots of land and also paid the land revenue of the said plots of land and in this way, I had/have been possessing the said plots of land having my permanent heritable and transferable right, title, interest and possession therein.

Sir, it is stated on 13.05.2015, I got the phone call from some persons have entered into my land and have accumulated the construction materials such as the sand, cement, gitti etc., for the purpose of some construction and on getting such information, I rushed to the spot and found that some laborers under the leadership of one Rabi Roy Son of Late Din Nath Roy, resident of Jamadargachh, Post office Balaram, PS. NJP [previously Bhakti Nagar] District : Jalpaiguri and others are digging the said plots of land to make the drain and when I interfered into the matter and asked them for digging of his said land, then they become furious and abused me and my man in filthy language and threatened with dire consequence and accordingly I also diarized the matter to the police. Subsequently, I came to know from the said persons that the said Rabi Roy and one another Mr.Kameel
