in producing herewith the one arrested accused person namely Mukul Singha 28yrs s/o Late Biswanath Singha of Boot Toran Jote PO+PS, Naxalbari Dist, Darjeeling along with the seized Vehicle bearing registration no WB73E/6724 (Tractor with Trolley) loaded with sand, I beg to submit that on 11,05,2022 in course of my K-36 evening mobile van duty along with force C/540 Mintu Barua and LC/1320 Babita Singh, vide GDE No. 501 dtd, 11.05.2022 correspondence to Bagdogra PS, MCC No 2072/22 Dtd, 11.05.22 in course of evening van duty at around 19.05 hrs as per reliable source information we reached at Jungli Baba more and started search incoming vehicle from Naxalbari side and found that the mentioned Vehicle WB73E/6724 (Tractor with Trolley) was coming towards Bagdogra side along the road and intercepted the same. On searching, the said vehicle was found fully loaded with sand. On demand, the accused person Mukul Singha driver of the Vehicle RC No WB73E/6724 (Tractor with Trolley) failed to produce any valid documents or license in support of him for lifting and transportation of the sand on interrogation he admitted that the sand he loaded from Meechi river bed Naxalbari for sell at Bagdogra to his designated customers. So, there is sufficient ground to believe that the said loaded sand were taken either theft or any other fraudulent means and for which, I seized the Vehicle bearing RC No. WB73E/6724 (Tractor with Trolley) loaded with sand under proper seizure list maintaining all formalities, the seizure process was made in between 20.45 hrs to 21.15 hrs and subsequently arrested the accused person Mukui Singha u/s 41 CrPC observing all formalities and inform him ground of his arrest. As he violated the Government order vide org no 147/CORD CELL Dated 28.04.22 correspondence to DOP, HQ Org No 164/SPC Dtd, 29.03.22 and earlier org no 33 / SPC Date: 27 / 01/ 2022.

During interrogation, he confessed his guilt that he was carrying sand loaded in said Vehicle RC, no WB73E/9586 (Tractor with Trolley) being lifted from Tarbandha river ghat as per direction of Suman Ekka owner of the vehicle for their illegal gain without any valid document on support of loaded sand as well as his vehicle

Under the above fact and circumstances, I pray to your honour that a specific case under proper section of law, may kindly be registered against Mukul Singha 28yrs s/o Late Biswanath Singha of Boot Toran Jote PO+PS, Naxalbari Dist, Darjeeling the driver of Vehicle and Ram Chabilal Giri @ Pandit owner of the vehicle WB73E/6724 (Tractor with Trolley) arrange for its investigation.
