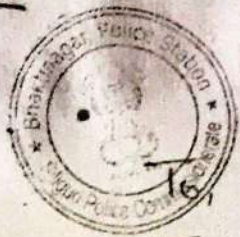

I had parked my bike near Payal Cinema Hall's  
parking in the main road. Where the parking  
person came to me and said this is not the  
parking place for parking a bike. I said him,  
I just will wait here for 5 mins but he  
forcefully said you need to move your bike.  
So, I said there is place to park so.  
What is the problem. So, first 2-people  
came and started to push me and then  
started to hit me. I also, started to  
defend myself for my safety. Then  
suddenly 10-15 people (not sure how many)  
came to the parking area who seemed  
to be friends with the parking incharge,  
and started to kill me with a knife & a  
iron rod. After that I got unconscious.  
Next I remember being with some traffic police  
officers.
