I, Rajib Dutta (40) S/o Sri Chandan Dutta, resident of Subhashini Bhawan (Zaika Biryani Building), M.N. Sankar Road, Dangipara, Ward No. 6 SMC, PO-Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling beg to inform you that, on Dt. 09.05.2022 at about 00:30 Hrs, in the midnight, when I was going to my home at M.N. Sankar Road, Dangipara and reached, opposite Nabatherat club, at that M.N. Sankar Road at that time, one car bearing Regd. No. SK-01-PB-8001, crossed me in a rash and negligent way, spreading road water and when I became wet due to that spoiled road water, I started at them than the unknown driver/owner of the vehicle No. SK-01-PB-8001 got down with his unknown associate from his car holding Iron Car Bench & lever of car steel and attacked on me by said weapons with intention to kill me, I received severe injury on my person and immediately rushed to Siliguri Dist. Hospital and treated myself there. They left the place of occurrence threatening me to kill next time.

So, please take necessary action against the unknown Driver/owner of the car bearing Regd. No. SK-01-PB-8001 and his one unknown associate, who was accompanying him on the date & time of the occurrence of the said incident.
