Sir,

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Rabindra Nath Banerjee (Present User), 43, Rash Behari Sarani, Hakimpara, Dist- Darjeeling for having committed offence as stated here under:

On 10.05.2022 at about 02.15 p.m. acting on a source information I, along with 1) Sri Malay Kr. Goswami, DE(E), S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential building of Rabindra Nath Banerjee and inspected service installation, metering installation of Consumer ID 412136686 in the name of Rabindra Nath Banerjee and Consumer ID 412152795 in the name of Lt. Kishori Mohan Bannerjee, which are disconnected & defaulted service connection. During inspection it was found that present user Rabindra Nath Banerjee unauthorisedly & illegally reconnecting the disconnected service line of Con Id. 412152795 in the name of Lt. Kishori Mohan Bannerjee that was disconnected previously on 03.02.2020 and supplying electricity from the same meter unauthorisedly and illegally to the disconnected & defaulted premises of Consumer ID 412136686 in the name of Rabindra Nath Banerjee that was also disconnected previously on 11.02.2021 due to non-payment of outstanding energy bill.

As unauthorised supply of electricity to the disconnected & defaulted premises was detected the energy meter make Bentec Electricals & Elec Ltd, serial no.- IPB257464 installed against Con Id. 412152795 seized by preparing a formal seizure list duly signed by representative of Rabindra Nath Banerjee and witnesses. The copy of the seizure list handed over to representative of Rabindra Nath Banerjee and his signature obtained as token of receipt.

As Rabindra Nath Banerjee have committed offence u/s 138(1)(a) & 138(1)(b) of Electricity Act 2003 by supplying electricity illegally & unauthorisedly to the disconnected & defaulted premises, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
