Sir,

I, Smt Subhra Das w/o late Pulak Kumar Das, aged 69 years residing at 07, Dinabandhu Mitra Sarani, Netaji More, Subhaspally, Siliguri beg to state that, I now live in a house owned and build by my husband. My son Aninda Das @ Bubai also lives in the same house with his wife and daughter. My husband died on 18th May 2021.

My husband executed a "WILL" bequeathing all his properties to me and by virtue of that will I am the exclusive owner of the Properties left by my husband. I have already filed a petition seeking probate of the will.

Now my son Aninda wants to grab the entire property by force and today at or about 10.30 am my son had suddenly attacked me caught hold my throat with a view to strangulate me. He also assaulted me physically causing severe bodily pain. He threatened me that he would kill me if the property is not given to him. The incident took place in my residence.

I am scared. I apprehend that he may make an attempt on me once again at any moment. The delay in lodging FIR is on account of state of shock through which I had to go.

I now request you to take appropriate steps for saving me from the impending danger and prosecute my son according to law.
