6. One iron rod measuring about 45 cm (approx) seized from the possession of accused Raj Mandal
7. One iron rod measuring about 45 cm (approx) seized from the possession of accused Gopal Das

I, PSI Rantu Haldar of Bhaktinagar Police Station under Siliguri Police Commissionerate do hereby lodge this suo-moto complaint against the above noted accused persons to the effect that, on 11.05.2022 at about 23.35 Hrs received a source information that some 10 to 12 youths have assembled at Gandhi Maidan, under Bhaktinagar PS, SPC making preparation to commit crime at that area. Accordingly the information was intimated to I/C Bhaktinagar PS and noted the fact in G.D vide Bhaktinagar PS GDE No-659 Dated 11.05.2022 and as per his direction, myself along with, ASI Nitai Mandal, C/986 Rajib Sarkar , CVF/935 Biplab Roy, CVF/619 Dharmendra Roy, CVF/014 Labannomoy Barman left PS to work out the information. Inform night mobile van officer PSI Sabin Yonzon Tamang and requested him to accompany the raid team. At 00.05 hrs I along with force reached at Gandhi Maidan and as shown by the source we subsequently cordoned off the place and suspected persons with a strong reason to believe that they were

fled away but on hot chase we managed to apprehend above noted 07 persons along with seized articles as mentioned above and detained all of them. However, the other persons managed to fled away from the spot taking the advantage of darkness. On interrogation the apprehended accused persons admitted that they had assembled there to commit dacoity at one of the house at Bhaktinagar PS area. They also stated that other persons fled away from the spot.

I thereafter, seized the above noted weapons under proper seizure list and labeled duly signed by the witnesses and acknowledged by the accused persons. (The whole seizure was made on 12.05.2022 in between 00.45 hrs to 01.35 hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrest duly signed by the accused persons..

I accordingly brought the arrested accused persons along with seized article at Bhaktinagar Police Station for further investigation. During interrogation, they stated that they assembled there to commit dacoity in a house at Bhaktinagar PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons 1] Subhodip Paul(18) S/O- Goutam Paul of Chayanpara, Amtola near kali mandir, PS Bhaktinagar, Dist. Jalpaiguri 2] Subham Sikdar (20) S/O- Manik Sikdar of Haidarpara, Sarat chandra pally, new water tank, PS Bhaktinagar, Dist Jalpaiguri 3] Krishna Haldar(23),S/O- Ram Haldar of Amtala Chayanpara, near health center, PS Bhaktinagar, Dist. Jalpaiguri 4] Ajit Roy (24) S/O- Lt Pran Ballab Roy of South Shanti Nagar, near radha Krishna mandir,, PS Bhaktinagar, Dist. Jalpaiguri 5] Nabiul Miya (23) S/O- Aminul Mia of South Shanti Nagar, near radha Krishna mandir,, PS Bhaktinagar, Dist.
