Sir,

In producing herewith one arrested Bangladeshi lady namely; Fatima Begum (30) W/O Rabiul Sheik of Fulbaria Bazar, PS – Salta, Dist. Faritpur, Bangladesh under proper escort of lady constable.


In this regard, I beg to report that on 12.05.2022 at around 07.10 hrs, myself along with force C/506 Ashok Oraon, C/934 Mukul Basu & LCV/1060 Goma Bhandari while performing K-37 III Van duty vide GDE No. 652 Dated 11.05.2022, received secret source information that one Bangladeshi lady without any valid documents waiting for Bus at P.C. Mittal Bus Stand. I immediately, shared the information with I.C. Bhaktinagar PS, SPC and as per his direction, conducted raid at PC Mittal Bus Stand. Being shown by the source, I along with force and Lady Civic Volunteer Goma Bhandari detained one lady. On interrogation, she disclosed her name and address as noted above. She further admitted that he entered into India from Cooch Behar side without any valid passport and Visa or valid paper and she was from Bangladesh and entered India looking for some job. With no option left, I arrested her with the help of Lady Civic Volunteer at 07.30 hrs issuing proper Memo of arrest U/S 41 CrPC maintaining utmost decency and informing her ground of arrest.

Hence, I pray that a specific case may kindly be initiated under proper section of law against the above mentioned lady and cause its investigation.
