I Smt.Swapna Saha, W/O Sri.Shymal Saha, , Resident of Baghajatin Colony, Pradhan Nagar, P.O Pradhannagar, P.S Pradhan Nagar, District: Darjeeling would like to draw your kind attention to the following effect that on 16th February 2001, I purchased a land measuring about 4.5 kathas recorded in R.S Khaitan number 417/1, R.S Plot No. 676(part) and 677(part), mouza-Siliguri from Sri. Uttam Saha and Smt.Dipali Saha vide registered deed no. 1-744 executed and finally registered in the year 2003. Thereafter the aforesaid land was mutated by the concerned authority vide M.C Case No.429/IX-II of 2003 and also paid Khaina regularly and SMC Holding Tax. After purchasing the land I constructed 3 Shop Yooms and I godown with a tin roof. Subsequently I leased one shop room and one godown to Pradip Chowdhury on rent in the year of 2012 for a period of 11 months after inducement of the said Pradip Chowdhury, accordingly one agreement was executed in between me and Pradip Chowdhury and other two rooms were given to Samir Roy and Uttam Saha on rent but the said Pradip Chowdhury after 11 months continued the tenancy as per the verbal nspector in Paying the rent and I suddenly received a summon from the Ld. Civil Judge (Jr. Division) agreement and he used to pay Rs.16,500/- to me per month but after sometime he stopped Inspector Police Court at Siliguri dated on 26.11.2018 being T.S No. 270/18 where I appeared and filed my Prodhan Police Court at Siliguri dated on written statement which is will asset to the court of the court o Pradip Chowdhury filed a Title suit against me and my husband and obtained an order of Interim Injunction against me and my husband by filing forged Title Deed being No. 2381 dated 21st October 2016 in the name of the Pradip Chowdhury as a purchaser in respect of my aforesaid land one rent receipt/khazna, one purported searching report and those document were prepared after hatch-up a deep rooted conspifacy with aforesaid people to grab our land. In a Title Deed No.2381 dated 21st October 2016 the name of the seller mentioned as Keshab

Prasad Pradhan but when I met Keshab Prasad Pradhan he told me that he did not sign the sale deed being No.2381 dated 21st October 2016. I finding no other alternative filed a complaint against Sri. Pradip Choudhury and four others in Pradhan Nagar Police Station being FIR No.718/18 dated 17/12/2018 and it is also pertinent to mention here that the accused persons have been charged under sections 406,420,465,466,467,468,471,120B and the accused persons are on bail. But at that time I was not aware about the involvement of the bank manager in the conspiracy to grab my property. I came to know that Pradip Chowdhury with the conspiracy of the above named persons hatched up a deep rooted conspiracy to cheat by depositing his forged title deed being No. 2381 dated 21st October 2016 in United Bank of India , Sevoke Road Branch, Siliguri now at present Punjab National Bank, Siliguri and took loan more than Eighty Lakh therefore he along with above mentioned persons also committed the economic offence, forgery, mis-persuasion, cheating etc and the aforesaid Pradip Chowdhury also in this way tried to grab my land. Pradip Chowdhury along with the then Bank Manager of United Bank of India together hatched up a conspiracy along with the persons above mentioned 5,6,7 and 8 and other anti-social.

I came to know that the leased property of which I am the rightful owner, which was falsely used by the lessee Sri. Pradip Choudhury for procuring a loan of Rs.98,32,631.50/-(Rupees Ninety Eight Lakh thirty two Thousand six hundred thirty one and fifty paise only) by fraudulently forging a deed and other documents in his name is going to be auctioned on 12th August 2021and when I went to inquire about the auction the present manager of Punjab National Bank (after merger with United Bank of India), Hill cart road branch, Siliguri heckled and harassed me. Also, he and his associates girdled me and asked me to sell the property. And when my daughter Subarna Saha rushed to the main branch of Punjab National Bank, Sevoke road for inquiring about the auction, the manager of the said bank misguided my daughter and told her that we should sell the land to their buyers otherwise we will not get any of the property. Thereafter I prefer an application before the DRT court at Siliguri, and I filed Declaration Suit being No. 102 of 2021 and an eviction Suit being No. 9 of 2022 and a before the Civil Judge (Sr. Div) at Siliguri and that is pending.

On 62.68.21 lodged a written complaint against the above named persons but no steps were taken against them in your side till date, and I am in dark whether my previous complaint treated as a complaint/ FIR or what. Today again I made this complaint before you to investigate the matter properly and punish them in accordance of law
