Sir,
I, Souvik Bhadra and my wife Shayeri Roy, both residents of Kolkata, are travelling from Bagdogra Airport to Kolkata Airport today via Spicejet flight.

In the airport, during check-in process, at around 2-3 pm, of Gujarati/Hindi speaking passengers, a large group tried breaking the queue, travelling gathered around and started an altercation, in spite of my efforts to convince them to follow the queue, they shouted and insulted me and my wife. The matter escalated as both of us protested. They personally assaulted me and my wife without any provocation. They pushed me hard and encircled both of us, thereby wrongfully restraining us. Thankfully some CISF personnel intervened and restrained them.
