Sir,

I, Vineet Hisariya, resident of Hillcart Road, Siliguri Ward no.: X (S.M.C), P.O. & P.S.: Siliguri, Pin no.: 734001, District: Darjeeling, State of West Bengal, would like to lodge a F.I.R. against (1) Mohit Tiwari, S/o Manoj Tiwari and (2) Manoj Tiwari, S/o Late Ram Naresh Tiwari, both resident of Flat no.: 3E, shantiniketan Apartment, Kawakhali, Siliguri, District: Darjeeling, under the following ways:

1. The above named Mohit Tiwari had purchased a landed property from my Mother-in-law named by Sharbari Sharma in the year 2021 by way of Sale Deed at Hillcart Road, Siliguri Ward no.: X (S.M.C), P.O. & P.S.: Siliguri, Pin no.: 734001, District: Darjeeling, State of West Bengal, adjacent to our property.
2. That since then they had been constructing a multi-storied building without following proper guidelines laid by Siliguri Municipal Corporation for building to which we had made several request to which they never paid a heed.
3. That today on dated 10-05-2022 at about 11:30A.M. I heard some noise from back of my building, I went there and found out that the above named persons have illegally tress-passed my property from the backside boundary wall of our building and illegal without any consent from me or my family they have put bamboo structure, also blocking and damaging my room window and made one wooden box covering outside part of an A/C of my room.
4. That seeing this illegal property tress-passed and making a wooden box almost damaging my A/C and Window of my building their mala-fide intention could be seen. I immediate showed my remorse and asked both the person to take-off the wooden box immediately but the refused to remove it and just took off the

bamboos from there and started to threatened me and my family with dire consequence and if we dare to make an issue out of it or inform anyone or lodge any complaint then he will not spare us and nothing can stop him from doing what he wants to do.

5. That it is also pertinent to mention here that I had also dialed 100 and called for help, in few minutes police personnel from panitanki T.O.P had arrived at the place of occurrence and enquired about the said incident and also spoke to both the above mentioned persons to which they refused to take off the wooden box in front of the police personnel also.

That I would like to request to take an immediate legal action against the said Mohit Tiwari and Manoj Tiwari and help us in this tough situation as both the persons are continuously threatening us with dire consequences.
