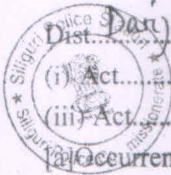

Sir, I Sri Manoj Kumar Tiwari S/o Late Ram Narsh Tiwari resident of Sreema Sarani, Babupara, P.O & P.S - Siliguri, District - Darjeeling would like to inform you that I have a Diagnostic Centre under the name and style Rama Diagnostic Polyclinic Pvt. Ltd having its office at Hill Cart Road, Opposite Viniak Hotal, Siliguri, Darjeeling. My neighbour Vinit Hishariya* S/o Uttam Haishariya has installed one Air condition machine covering my passage and due to said Air conditioner Machine, the water of A/C Machine profoundly fall in my passage causing I along with my staffs and patients used to suffer with a lot due to his A/C Machine. And to protect my passage from wet, yesterday I have covered the outer machine of A/C to protect my electricity meter and to protect from any incident supposed to be happen due to electrocution. Further to be mention here that on 23 - 3 - 2022 I have asked and requested the said Vinit Hishariya to remove the outer machine of A/C from my passage but inspite of assuring me that he will remove the same very soon but have started neglecting to remove.

Due to their said illegal installation of outer machine of their A/C machine, I am suffering with alot and they are continuously creating nuisance with me for the reason best known to them .
