Sir,

In producing herewith one (01) arrested accused person namely Gulsad Md. (22) s/o Md. Hafizuddin Seikh of Mallaguri, Ratanlal Busty, PS Pradhan Nagar, Dist Darjeeling along with the following articles under proper seizure as per seizure list;

- a) One Black carry bag containing 30 (Thirty) bottles of "REXDRYL" Cough Syrup (each bottle containing 100 ml) having Batch No. 010720-MB11, Mfg. Date: 06/2020. Exp. Date: 06/2022 which was kept inside one nylon plastic (black) - seized from the possession of above noted Gulsad Md. (22) and marked as "Exhibit- A".
- b) One (01) bottle of "REXDRYL" Cough Syrup (containing 100 ml) randomly taken from "Exhibit- A" for examination and marked as "Exhibit A-1".

I, SI Abhishek Theengh (32), S/O- Sri Suchandra Kumar Theengh of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Gulsad Md. (22) s/o Md. Hafizuddin Seikh of Mallaguri, Ratanlal Busty, PS Pradhan Nagar, Dist Darjeeling to the effect that on 13.05.2022 at about 14:25 hrs I received a specific source input that one person possessing huge quantity of 'Codeine Phosphate' based drugs was standing at Gurung busty more, near Mahananda Bridge under Pradhan Nagar PS to sell the same to their designed local customers. The matter was diarized in Pradhan Nagar PS GDE No. 906 Dt. 13.05.2022 and subsequently, I informed the matter to the Inspector-in-Charge, Pradhan Nagar Police Station in written and being directed, myself along with ASI Tarun Kanti Ghosh, ASI Ashit Singh, C/762 Mojibul Rahaman, CV-128 Ajay Kumar Sahani, CV-242 Rakesh Mangar, CV-223 Swapan Chettri and CV-646 Baban Das, all of Pradhan Nagar PS, SPC along with investigation kit left for Gurung busty more, near Mahananda Bridge under Pradhan Nagar PS by Govt. vehicle to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No. 908 Dt. 13.05.2022 and M.C.C No-1710/2022 Date- 13.05.2022.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offenders.

On way to Gurung busty more, near Mahananda Bridge under Pradhan Nagar PS, I contacted two persons namely (1) Bishal Ray (20) S/O Bablu Ray of Coolie Para, Ward No 1, P.O+P.S- Pradhan Nagar, Dist- Darjeeling and (2) Suraj Sah (19) S/O Biren Sah of Coolie Para, Ward No 1, P.O+P.S- Pradhan Nagar, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with above noted independent witnesses arrived at Gurung busty more, near Mahananda Bridge under Pradhan Nagar PS at 15.10 hrs and subsequently, being pointed by my source detained 01 (one) person standing at Gurung busty more, near Mahananda Bridge under Pradhan Nagar PS. He had carried one black carry bag under his possession. Thereafter, we disclosed our identity and the information in hand and stated him that he as well as the bag under his possession will be searched for the purpose. And, I gave him option in writing to be searched in presence of any Gazetted Officer upon which he agreed to be searched upon. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, they did not search the police party. Consequently, I contacted the matter to Shri Subasish Chaki I/C Pradhan Nagar PS and requested him for acting as Gazetted Officer of SPC for the day, regarding the interception of the accused person suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come at Gurung busty more, near Mahananda Bridge under Pradhan Nagar PS to remain present and to supervise the search and seizure.

Accordingly at 15.40 hrs Shri Subasish Chaki I/C Pradhan NagarPS, Siliguri Police Commissionerate detailed for acting as Gazetted Officer of SPC arrived at the spot at Gurung busty more, near Mahananda Bridge under Pradhan Nagar PS and in presence of two independent witnesses I searched the detained person following all the formalities, keeping his decency and recovered the above noted articles from the exclusive and conscious possession of the accused person namely Gulsad Md. (22) s/o Md. Hafizuddin Seikh of Mallaguri, Ratanlal Busty, PS Pradhan Nagar, Dist Darjeeling.

It has been found from the bag under the possession of the above noted accused person namely Gulsad Md. (22) containing 30 (Thirty) bottles of "REXDRYL" cough syrup (each bottle containing 100 ml) containing 30 X 100 ml = 3000 ml i.e., equivalent to 3.0 Kg].

Further, on demand in presence of Shri Subasish Chakil/C Pradhan Nagar PS, Siliguri Police Commissionerate detailed for acting as Gazetted Officer of SPC the detained persons namely Gulsad Md. (22) failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Thereafter, I seized the recovered 30 (Thirty) bottles [containing 3000 ml i.e., equivalent to 3.0 Kg] of "REXDRYL" Cough Syrup [including 01 (one) bottles of "REXDRYL" Cough Syrup (containing 100 ml) which were taken randomly from the mother packet for examination] from the exclusive and conscious possession of above noted accused person namely Gulsad Md. (22) at the spot at Gurung Busty more, near Mahananda Bridge under Pradhan Nagar PS under proper seizure list in presence of independent witnesses and Shri Subasish Chakil/C Pradhan Nagar PS, Siliguri Police Commissionerate detailed for acting as Gazetted Officer, SPC obtaining their signature and being acknowledged by the accused person.

Subsequently, I labelled and sealed the seized articles in presence of Shri Subasish Chakil/C Pradhan Nagar PS, Siliguri Police Commissionerate detailed for acting as Gazetted Officer, SPC and independent witnesses and the accused person namely Gulsad Md. (22). The whole process of seizure was made in between 15.50 hrs to 16.35 hrs.

Being further asked, the apprehend person namely Gulsad Md. (22) admitted in presence of Shri Subasish Chakil/C Pradhan Nagar PS, Siliguri Police Commissionerate detailed for acting as Gazetted Officer of SPC and other independent witnesses, stated that he have procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to his designed local customers for his personal gain by illegal means. He also disclosed that he has been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few months for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Gulsad Md. (22) is involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Gulsad Md. (22) after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Gulsad Md. (22) s/o Md. Hafizuddin Seikh of Mallaguri, Ratanlal Busty, PS Pradhan Nagar, Dist Darjeeling and arrange for its investigation.
