Respected Sir,

I, Sri Ganesh Tripathi, son of Late Lagandeo Tripathi, of Gurung Basti, Siliguri, P.O. Champasari & P.S. Pradhannagar, District- Darjeeling would like to inform you that I am the registered owner of the two lands (1) Land measuring about 5.6 decimals vide sale deed bearing Registration No. 6338 dated 18.11.2008 and (2) Land measuring about 14.625 Katthas vide sale deed bearing Registration No. 6389 dated 18.11.2008 and both falls under Mouza-Palash, in part of R.S. Plot No. 310, in R.S. Khatian No. 5, corresponding to L.R. Plot No. 879, L.R. Khatian No. 109, J.L. No. 63, registered in the office of ADSR Siliguri-II at Bagdogra, District-Darjeeling and the above-mentioned lands were purchased from Sanjeev Srivastave, son of Satya Narayan Srivastave of 103/1, Ram Lal Agarwal Lane, Kolkata. After the purchase, I enjoyed the peaceful physical possession of the aforesaid lands and also recorded my name in L.R. Khatian by the concerned authority in the year 2010.

But few persons namely (1) Palash Sarkar s/o Jag Bandhu Sarkar (2) Simul Das s/o Jyostna Das (3) Nagendra Tiwari s/o Late Rardeo Tiwari (4) Bapi Roy s/o unknown (5) Robin Roy s/o Ganga Roy (6) Manoj Tiwari s/o Bachha Tiwari (7) Jagabandhu Saha s/o Late Anandamahan Saha (8) Swapan Saha s/o Late Adhir Saha (9) Parimal Barman s/o unknown, and others (all are the residents of Dakshin Palash, near Jamai Bazar, P.O. Champasari and P.S. Pradhannagar, District-Darjeeling) hatched up a deep rooted conspiracy in respect of my aforesaid lands and with intention to cheat me for their illegal gain are trying to encroach upon my aforesaid lands by procuring some forged documents as well as other illegal means of which I am the lawful and absolute owner. Whenever I try to visit my aforesaid lands the aforesaid persons threaten me that they are influential people having muscle power and having no fear of law and warned me with dire consequences in case I try to seek help of law enforcement agencies. It is pertinent to mention here that on previous occasions for several times I gave written complaint to the concerned authorities but all efforts went in vain.

At present, I am 79 years old ailing person and fed up to move here and there for saving my aforesaid lands from illegal encroachment by the above-mentioned persons.

It is my humble and sincere request to you take immediate and necessary action against the above-named persons and charge them under relevant laws of the land.
