Sir,

In producing herewith one person namely Raj kr. Sahani (52) S/O Lt. Kari Sahani of Bimannagar PS, Bagdogra Dist, Darjeeling along with the following articles under seizure viz,

1. 21 (Twenty one) Himalayan Gold 60Up Contry Sprit (each bottle containing 600 ML) Marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1",

I, ASI Dilip Halder of Bagdogra Police Station, SPC do hereby lodged this written complaint against the above noted arrested person namely Raj kr. Sahani (52) S/O Lt. Kari Sahani of Bimannagar Ps, Bagdogra Dist, Darjeeling to the effect that on 13.05.22 in course of evening K-36 mobile duty along with force under Bagdogra PS, area vide MCC No 2105/22 Dtd, 13.05.22 at around 18.35 hrs received a secret source information that one person is selling huge quantity of illicit liquor at Bagdogra Airport more market area to his designated customers and as per your kind instruction, I along with Const/317 Kartick Roy and Const/ 778 Kamal Lama rushed at Bagdogra Airport More market area to verify the veracity of information. At around 18.50 hrs we reached at Bagdogra Airport more market area parked the vehicle in a considerable distance and approaching towards Bagdogra Airport market side source point out one shop in a distance we cordon the shop without styled seeing the police team he tried to flee away a hot chase police party managed to apprehended the above noted arrested person who is selling illicit liquors some of his designated customers clandestinely presence of police team some customers who was gathered for purchased liquor on his shop were flee away to run from the spot. On interrogation Raj kr. Sahani admitted that he is the owner of shop and run the illicit liquor selling business since long time for his wrongful gain on demand he failed to produce any valid documents or license on support of storing and selling the said huge quantity of illicit liquor recovered from his shop. Accordingly, I seized and labelled the above mentioned illicit liquor recovered on his shop under proper seizure list in presence of witness and arrested him u/s 41 CrPC issuing memo of arrest and inform his ground of arrest.. The whole process of seizure and labelled was made in between 19.05 hrs to 19.45 hrs. Total 12.600 ltrs illicit liquors.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted accused Raj kr. Sahani (52) S/O Lt. Kari Sahani of Bimannagar PS, Bagdogra Dist, Darjeeling and arrange for its investigation.
