

Respected Sir,

I, SRI SUSHIL MARDA, Son of Jiwan Ram Marda, Hindu by Religion, Indian by Nationality. Business by Occupation, resident of Naya Bazar, P.O. Siliguri Bazar & P.S. Siliguri in the District of Darjeeling – 734005 would like to lodge a complaint stating as follows:

1. That I along with my brother Sri Lalit Marda are the owner in possession of land measuring 2.66 Acre and 2.43 Acre appertaining to and forming part of R.S. Plot Number 284, 283, 286 & 287 at Sheet No. 9 of Mouza –Binnaguri, District – Jalpaiguri (morefully and particularly described in schedule herein below) by virtue of two Deeds of Conveyance being Document No. 31 and 32 both for the year 1987.
2. That One Paltan Singh Roy and Nathuri Ram Kanu were the recorded owner of the R.S. Khatian 2814 having total area measuring about 30.82 Acre. During his lifetime the said Paltan Singh Roy sold and transferred entire land of Khatian 2814 by virtue of deed of sale being document numbers 2678 for the year 1954, 237 for the year 1956, 2967 for the year 1958, 3736 for the year 1958, 548 for the year 1958, 2953 for the year 1960, 6740 for the year 1961, 3044 for the year 1961, 4902 for the year 1961, 515 for the year 1962, 5029 for the year 1962, 5584 for the year 1962, 5029 for the year 1962, 6399 for the year 1963, 6271 for the year 1963 and 6225 for the year 1968.
3. That from deed of conveyance being document no. 237 for the year 1956 sold to Manu Rani Bose, I along with my brother Lalit Marda purchased land morefully described in schedule below from the said Manu Rani Bose.
4. That on the year 2012 one Sri Manbahadur Gurung S/o K.B. Gurung, Resident of Rong Busty, P.O. Sumbuk, South Sikkim alleged to have purchased a piece and parcel of land measuring about 10 Bigha 7 katha 14 Chhatak from legal heirs of Paltan Singh Roy and started to disturb our physical possession. On the basis of the abovementioned purchase said Manbahadur Gurung previously had filed a Title (Partition) Suit No. – 55 /2012 against us and thereafter when we filed the reply in the case he came to know that he has
