Subject: - First Information Report.

Respected Sir/ Ma'am,

I, Binod Kumar Agarwal, son of Late Ram Kumar Goyal (Agarwal), temporarily residing at M.C. Market, Khalpara, P.O. Siliguri Bazaar would humbly state the following –

1. That I am the son of Late Ram Kumar Goyal, and that my father had passed away in the year 2008. My father was the owner of a land measuring 115 decimals, situated within Pargana Baikunthapur, Mouza Binnaguri, P.S. & S.R. Office Rajganj, Dist. Jalpaiguri. The said land appertains to Khaitan No. 501/1, 501/2, Sheet no. 16, Plot no. 276.
2. That my father is the owner of the said land and has mutation in his name (Annexure A) and has been in possession of the same since the past 20 years.
3. That on April 3, 2022, the following people entered my land illegally –
  - i. Md. Younus, residing at Kalingini, West Bengal. (Phone - 8158046435)
4. That the persons named under Point 3 are known land grabbers and land mafia in the local area where my land is situated and that their modus operandi is to illegally enter a vacant land and forcefully obtain illegal possession of the same and extort money from the land owner.
5. That these persons entered my land on April 3, 2022 and illegally embedded markers on the land. That the said persons are also demanded money in order to vacate the land and for future non interference, failing which they threatened to illegally occupy my land and make a boundary wall.
