Sir,

In producing herewith the 01 (one) arrested accused person who disclosed his name & identity as Rajesh Mahato (20 year) S/O- Joginder Mahato C/O- Late Pahelwan Mahato of Santoshinagar, near Machli Bazar, ward No. 05, PS- Siliguri, Dist- Darjeeling who was arrested on 13.05.2022 in c/w the case. I ASI Md. Aminul Islam of Khalpara TOP under Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted arrested person and 7/8 others. The fact of the case is that, on dated 13.05.22 at about 21.15 hrs, in course of special R/T mobile duty, myself along with SI Subhendu Das, SI Md. Shajahan Ali, ASI Sanjoy Handa, C/1187 Ganesh Sarkar & CV/874 Amaresh Sha all are Khalpara TOP under Siliguri PS, SPC had been to Santoshi Nagar area and received an information from my source that above noted arrested accused person selling illegal liquors at his house. Accordingly, we held raid at his house noted above but all of sudden, the above noted arrested accused person and 7/8 others local persons became violent and hit me with fist and blows but somehow I managed to dodge the hit. But he caught hold my shirt tightly and torn my uniform and also damaged the back side glass of Govt. Vehicle of Khalpara TOP having registration no. WB 24Y/ 5978. However, I able to arrest one accused person namely Rajesh Mahato (20 year) S/O- Joginder Mahato C/O- Late Pahelwan Mahato of Santoshinagar, near Machli Bazar, ward No. 05, PS- Siliguri, Dist- Darjeeling u/s- 41 Cr.P.C after observing all rules and formalities and others were managed to fled away from the spot.

Under these circumstances, I pray before you that, stern action may kindly be taken against the above noted arrested accused person and 7/8 others for using criminal force to Police personnel in uniform, obstructing Public servant and causing hurt to deter public servant while discharging my government duty, damaged the Govt. properties.
