Sir,

With due respect, I PSI Sumit Sarkar of Matigara P.S, SPC do hereby lodge this Complaint to the effect that on 10.05.2022 at 14:10 hrs onwards in course of special Mobile van duty vide Matigara PS GDE No. 524, Dated- 10.05.2022 received information that some illegal transpiration river bed materials is going through 99 More, New Rangia under Matigara PS area. Accordingly after sharing the information with O/C Matigara PS and as per his kind instruction myself along with my accompanied force had been to New Rangia near 99 more to verify the veracity of the information.

On reaching at New Rangia near 99 more found from a distance that one Tractor having Reg. No. WB -73 E/8962 coming from Tarabari river Ghat towards Matigara loaded with river bed materials. At that time seeing the Police team approaching towards him, he fled away from the spot leaving the tractor behind him. Accordingly, I seized the Tractor bearing Reg. No. WB -73 E/8962 loaded with river bed materials under proper seizure list and brought at PS compound.

Therefore I pray before you that a specific case may kindly be started against the absconding driver/owner of the vehicle Reg. No. WB -73 E/8962 under proper section of law and arrange for its investigation.
