I, Smt. Balika Debi Chowdhury, wife of Late Rajmal Chowdhury, resident of Goyal Jote, P.O. Nimai, P.S. Matigara, Dist. Darjeeling, PIN 734010, West Bengal, would like to inform you to the following facts and taking necessary action please:-

- 1. That I had purchased a land measuring 16.50 decimals recorded in Khatian No. 110, in R.S. Plot No. 29 corresponding to L.R. Plot No. 31, within Mouza-Nimai, J.L. No. 57, under Matigara P.S. from one Sri Man Mohan Barman, son f Late Chikaru Barman of the same my residential address and registered at office of the Sub-Registrar, Siliguri on 20.02.1989 vide Deed No. I-1329 for the year 1989.
- 2. That thereafter I have possessed the same and peacefully enjoying without any disturbance of the aforesaid purchased land.
- 3. That now the day I am very poor old widow and due to old age I am suffering from various ailment, while I have two sons and three daughters but no one look after me properly except my youngest daughter Mamta Chowdhury and reside with her.

Before decamped my premises they threatened they will kill me, my sons and daughters and also threatened not to raise this matter to anybody or anywhere. Sir, it is prominent to crystal clear that their intention is to grab my said property by any way or with lure of some money and on the basis of forcefully thumb impression, muscle power and different types of threatening.
