Sir,

I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complaint against Sri. Sushil Karmakar (ph no- 8167086260), S/O Lt Balachand Karmakar, resident of Bholanath Para, P.S Bhaktinagar, Dist Jalpaiguri, West Bengal. While on a routine inspection on the site having consumer id 400276859, meter no L1570990, I, Suman Sengupta, Divisional Engineer & Station Manager, Power House CCC along with Sanjay Prasad, Sr Office Executive, Power House CCC, WBSEDCL and other technical staffs observed that the power from the said meter was being provided in a different premises even after reconnecting the same un authorizedly, which was disconnected for outstanding dues.

We entered the premises at 1248 hrs on 13.05.2022 after handing over Notice to Smt Rina Karmakar (daughter In Law of Sushil Karmakar). Then it was observed that the power was being used in an unauthorized manner, by providing power to different premises where the power was not authorized for. While on the other hand the connection was already disconnected on 30.12.2019 due to OSD having of Rs 4,536.14/-, but the connection was found to be reconnected in an unauthorized manner on site. Therefore committing a crime for theft of power as per section 135 (1) (e)/138 (1) (b) of the Indian Electricity act 2003 amended on 2007. Accordingly the connection was disconnected and the energy meter and service cable were seized and labelled. A copy of both inspection report and Seizure list (1. Landies & Gyr make, SI No L1570990, 1 Phase, (240 Volts), (5-30) amps, property of WBSEDCL, & 2. Service Cable of Black & Red In Color, 6 Sq mm, Single Stranded, Double Core Aluminium PVC wire of 10 meters approx ) were handed over to Sri Sushil Karmakar. We exited the premises at 1315hrs.

Thus you are requested to kindly initiate an investigation against Sri. Sushil Karmakar under Section 135 (1) (e)/138 (1) (b) of the Indian Electricity act 2003 amended on 2007 of India.
