(1) 15 (Fifteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total- 9 Liter & Amount Rs 1800/-).

I SI Pradip Kr Singh of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely Kali Mohan Roy (27), S/O- Sri Kaltu Roy of Hasuapara PO Prashna Nagar PS Rajganj Dist. Jalpaiguri, Present address- Khudiram Coloney Ektiasal PS Bhaktinagar Dist.
