In producing herewith one accused person namely Kali Mohan Roy (27), S/O- Sri Kaltu Roy of Hasuapara PO Prashna Nagar PS Rajganj Dist. Jalpaiguri, Present address- Khudiram Coloney Ektiasal PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

- (1) 15 (Fifteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total- 9 Liter & Amount Rs 1800/-).

I SI Pradip Kr Singh of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely Kali Mohan Roy (27), S/O- Sri Kaltu Roy of Hasuapara PO Prashna Nagar PS Rajganj Dist. Jalpaiguri, Present address- Khudiram Coloney Ektiasal PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 14.05.2022 evening as per order of O/C Ashighar OP I along with ASI Krishna Ch Singha C/ 877 Munna Ahmed and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no. 322 Dt 14.05.2022 in course of which I received information from my source that one Kali Mohan Roy kept some of bottles of liquor inside a bag and selling the said bottles of liquire by turning gouge the local youth of Khudiram Coloney Ektiasal in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Khudiram Coloney Ektiasal area to verify the veracity of information. On the way I called two local person namely (1) Dilip Das (37) S/O Kali Charan Das of Ghogomali PS Bhaktinager Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Badurbagan PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Khudiram Coloney Ektiasal area as indicated by my source I along with my accompanied party surrounded the said Kali Mohan Roy at Khudiram Coloney Ektiasal. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched the above noted accused person, in course of which I recovered the above noted bottles of liquor which were kept inside a bag carrying by him. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 21.25 hrs and 21.45 hrs on 14.05.2022.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Kali Mohan Roy (27), S/O- Sri Kaltu Roy of Hasuapara PO Prashna Nagar PS Rajganj Dist. Jalpaiguri, Present address- Khudiram Coloney Ektiasal PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
