Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Raju Roy (19 yrs) S/O Debraj Roy of Dagapur, Bandri Jote, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Md Sazzad Sha (21 Yrs) S/O Md Guffar Sha of Vill- Jokihat PS- Jokihat, Dist - Arariya, Bihar (iii) Md Anupam (20 yrs) S/O Md Rafik of Bibekananda Road, Khalpara, PS- Siliguri, Dist.- Darjeeling and (iv) Mithilesh Malakar (22 yrs) S/O Late Laxman Malakar of Jabrabhita, PS- NJP, Dist.- Jalpaiguri and the following articles under seizure :-

1. One iron made sharp cutting weapons called as Hasua from the possession of accused Raju Roy S/O Debraj Roy of Dagapur, Bandri Jote, PS- Pradhan Nagar, Dist.- Darjeeling.
2. One iron made sharp cutting weapons called as Bhojali from the possession of accused Md Sazzad Sha S/O Md Guffar Sha of Jokihat PS- Jokihat, Dist - Arariya, Bihar.
3. One sharp cutting knife and one torch light from the possession of Md Anupam S/O Md Rafik of Bibekananda Road, Khalpara, PS- Siliguri, Dist.- Darjeeling.
4. One sharp cutting Bhojali and one torch light from the possession of accused Mithilesh Malakar (22 yrs) S/O Late Laxman Malakar of Jabrabhita, PS- NJP, Dist.- Jalpaiguri.

I, SI Goutam Mallik of Matigara PS, Siliguri Police Commissionerate beg to state that on 14.05.22 at 01.15 Hrs received a secret source information that a gang of miscreants come at near Sadhan More under PS- Matigara, Dist.- Darjeeling with deadly weapons and assembled there and making preparation for committing dacoity at Rangia area. Accordingly, I diarized the fact in General Diary vide NJP PS GDE No 736 dated 14.05.22 and informed the fact to you as well as Asstt Commissioner of Police, west Zone, SPC about the information in hand. I also informed the fact to night RT Van officer SI Md Sanaullah and ASI Sanjoy Basunia and requested them to come to Sadhan More to accompany with us. At 01.45 hrs we arrived at near Sadhan more under PS- Matigara, Dist.- Darjeeling. After a few time RT Van officer SI Md Sanaullah and ASI Sanjoy Basunia along with force came to near Sadhan More and accompany with us. At about 02.15 hrs as indicated by the source we noticed that 09/10 persons assembled in a dark place near Sadhan more, PS- Matigara, Dist.- Darjeeling and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party managed to apprehended 04 (Four) of them with deadly weapons in their possession. On interrogation the apprehended accused persons disclosed their name and identity as noted above.

During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity at Rangia area. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested the above noted 04 (Four) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to Matigara PS. The search seizure and arrest made in between 02.45 hrs and 03.35 hrs on 14.05.22.


