In producing herewith arrested accused person namely Biswanath Chowdhury (60 yrs) S/O Late Bhagwan Chowdhury of Sukti Godown, PS- Matigara, Dist- Darjeeling along with seized articles vize i) 16 (sixteen) sealed Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs 120/- x 16 =RS.1920/-) in which one sealed bottle has taken out from mother packet box as sample as per seizure list.

I, ASI Tapan Das of Matigara PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Biswanath Chowdhury (60 yrs) S/O Late Bhagwan Chowdhury of Sukti Godown, PS- Matigara, Dist- Darjeeling to the effect that on 14.05.22 at 18.05 hrs acting on secret source information that the above noted person was busy to sale ld liquor illegally at his shop situated at Sukti Godown under Matigara PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Matigara PS GDE no.780 dated 14.05.22 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with C/974 Mintu Sen, C/374 Debraj Biswas and CV/155 Sukumar Das both of Matigara PS left for Sukti Godown under Matigara PS to verify the veracity of the information. On reaching at 18.25 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, he disclosed his identity as noted above. On being asked he stated that he used to sale the 60 up Country Spirit to locality without any valid documents as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. On searching i) 16 (sixteen) sealed


Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs 120/- x 16 =RS.1920/-) in which one sealed bottle has taken out from mother packet box as sample as per seizure list which was kept concealed in his house under Matigara PS. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since long for his wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 19.25 hrs and 20.50 hrs. As such I arrested him U/S-41 Cr.P.C after observing all sorts' of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Biswanath Chowdhury (60 yrs) S/O Late Bhagwan Chowdhury of Sukti Godown, PS- Matigara, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
