I smt. Kanan Sarkar w/o Late Jaganath Sarkar, aged about 54 years, resident of Buniadpur, P.O- Buniadpur, P.S - Barshihari, Dist:- Dakshin Dinajpur, Pin- 733121, State of West Bengal, beg to state as follows:-

1. That my complain against the following Person;-
 - (i) SRI. Kalyan Roy and Ananda Roy s/o Kalidas Roy resident of Mulajote, p.6/p.s- Bagdogra, Dist - Darjeeling.
 - (ii) SRI Samir Chakraborty son of late Kinskar Chakraborty, resident of Purba Saradapally, P.O- Kadamtala, P.S- Matigara, Dist:- Darjeeling.
 - (iii) SRI. Bholu Roy s/o late Bharat Roy resident of Indrapally, P.O- Kadamtala, P.S- Matigara, Dist - Darjeeling.
 - (iv) SRI. Arun kr. Das, Amin resident of Shivmandir Indrapally, P.O - Kadamtala, P.S - Matigara, Dist- Darjeeling
 - (v) SRI. Bishnu Roy s/o. son of Bharen Roy, resident of Rangia, P.O- New Rangia, P.S- Matigara, Dist- Darjeeling.
 2. That the fact is that I am old widow lady was cheated of Rs.7,00,000/- (seven lac) in the year 2019 by purchased the land of 2 katha 4 chatlak in mouza Bairatisal, J.L NO.70, plot No. 365(L.R), 339(R.S), Pargana - Patharghata, P.S - Matigara, Dist - Darjeeling, by virtue of Deed No.1 - 4103/2019 - dated - 15.07.2019. From Kalyan Roy and Ananda Roy and they purchased from Samir Chakraborty by virtue of Deed NO.1 - 5801/2018 and Samir Chakraborty purchased the land from (1) Bharat Roy (2) Bharen Roy (3) Haren Roy and (4) Rame Roy all are son of Haralal Roy and the sale Deed was registered on 23.09.2013 and Deed NO. 8710 and they are represented by constituted Attorney named - Bholu Roy and Bishnu Roy.
 3. That my site plan enclosed with sale Deed .. NO. I - 4103/19 was prepared by Govt. ... Arun kr. Das on dated 02/07/2019 and the measurement was completed in the presence of Bholu Roy and ... mentioned above.
 4. That after taking registry of my land and recorded /Mutated in Khation NO.7165. Plot NO.365(L.R) but After some month the same plot was claimed by Smt. Mukti Routh w/o Prakash Rout as she purchased the land by Virtue Deed NO. 5327 dated 28.03.2006, and also filing civil suit being no. 79/2014 and the suit is hereby in ex parte Samir Chakraborty sold the litigated land knowingly.
 5. That I am a old lady cheated of Rs.7,00,000/- (seven lac) and till now giving interest of loan to the Bank suffering mentally and physical Harasment.
 6. That the legal heirs of haralal roy repeatedly sold their raiyati land to different persons through constituted attorney.
- So, I do hope that you would be kind enough to take my F.I.R and investigate the matter and take action in favour of me.
