Subject- Fraudulent activities, forgery, Criminal intimidation, breach of trust, cheating i/c/w/ with our ancestral property situated at Ghyalal Sarani, North Mallaguri, Ward No. 46, PO- Champasari, PS- Pradhan Nagar, Darjeeling bearing plot no 4878, Khatian no.- 3343 and 3344 against Nawal Kishor Gupta (9851384151), Kanchan Gupta (8250595390), Dhruva Prasad (9733106344) and Madhuri Prasad (7001412969).

Sir/Madam,

This as reference to the subject his is to inform you that originally our father in law namely Late Rama Shankar Prasad Gupta was the legal owner of the said property and he was a recorded owner his name was recorded in the deed of rights kept with Govt of West Bengal i/c/w the land property and there was a structure on the said land property. Sri Rama Shankar Prasad Gupta died on 14.03.2006 leaving behind (04) four legal heirs namely 1. Gopal Parsad (since deceased), 2. Jaspal Gupta (since deceased), 3. Nawal Kishor Gupta and 4. Madhuri Prasad.

That the said land property was consisting of (02) two rooms, kitchen, bathroom and toilet. Sri Jaspal Gupta, S/o Lt Rama Shankar Prasad Gupta was residing there along with his son. That during the said stay it was a peaceful stay and nobody was having any objection to that effect and everything was going peacefully. That Sri Jaspal Gupta (since deceased) died in the year 2020 leaving behind (03) three legal heirs namely Bishyawati Gupta (wife), Navin Gupta (son) and Archana Gupta (daughter). And Gopal Parsad died in the year 1999 leaving (03) three legal heirs namely Mala Devi Parsad (wife), Dipendra Gupta (Son) and Anup Gupta (son).

That Nawal Kishor Gupta (55 yrs), S/o Late Rama Shankar Prasad Gupta, Kanchan Gupta (48 yrs), W/o Nawal Kishor Gupta both residing at 2, Ballen Villa Road, Darjeeling and Ghyalal Sarani, North Mallaguri, Ward No. 46, PO- Champasari, PS- Pradhan Nagar, Darjeeling, Dhruva Prasad (50 yrs), S/o Late Ram Swarup Prasad, Madhuri Prasad (48 yrs), W/o Dhruva Prasad both residing at Laxmi Cottage, R.N. Sinha Road, Darjeeling and opposite Nivedita Super Specialty Nurshing Home, Siliguri hatched up criminal conspiracy by fraudulent means with the intention of cheating in order to deprive and defraud us from the said property and also dispose off us and our children from the said property by wrongful means and activities. That the said persons with mala fide intention have manufactured some deed/documents and submitted to the Govt office, Block land Records Office, Court More, Siliguri in order to get their name retreated excluding us being the genuine heirs of the said property.

When we tried to stop/opposd them they used force and pushed us and threaten us with dire consequences and there is every possible chance of offences from their end at the said premisis. We, do hereby request your good self to treat this letter of complaint as the FIR report against the offenders and also to take all necessary steps as per the provision of IPC and book the offenders accordingly.
