Dear Sir,

I, Sri Hillol Kumar Das, Son of Kshitish Chandra Das, at present residing at Flat No.343, Block – 3, 4C, Green Valley Apartment, behind Vishal Cinema Hall, Post Office- Sevoke Road, Police Station- Bhaktinagar, District- Jalpaiguri, PIN- 734001 would like to inform you that I along with my wife Smt Tapobrata Das are the joint owners of a piece and parcel of vacant land measuring 6 (Six) Kathas and 10 (Ten) Chattaks appertaining to and forming part of Plot Nos. 96 (part) comprised in L.R. Plot Nos.566 corresponding to L.R. Khatian Nos.520 and 521 situated within Mouza – Dabgram, Sheet No.2 (LR), J.L. No. 2, Pargana – Baikunthapur, located within Kanchanjunga Complex, near Northern Flour Mill, under Ward No.42 of Siliguri Municipal Corporation, Police Station – Bhaktinagar, District – Jalpaiguri.

The aforesaid land was purchased by us by virtue of a Deed of Sale being No.1258 for the year 2009 and registered at the office of Additional District Sub-Registrar, Rajgnaj, District- Jalpaiguri. The land was sold to us by Sri Shiv Kumar Agarwal, Son of Late Shyamlal Agarwal. Thereafter we have been enjoying, holding and possessing the land and also mutated the land in our name.


After the purchase of the aforesaid land by us, we have also built a boundary wall. It is pertinent to mention here that one Mona @ Mrinal Paul, Son of Late Gour Gopal Paul (who is a veteran land mafia) along with his men and agent namely Sanjit Chakraborty, Son of Late Amal Chakraborty, resident of C/o. M&C Iron Stores, within Ward No.40 of Siliguri Municipal Corporation, Post Office- Haiderpara, Police Station- Bhaktinagar, District- Jalpaiguri after the purchase of the land have been forcefully trying to enter into our land and grab the same by showing some false and self manufactured documents. Further we have made an iron gate for the ingress and egress in our land. The aforesaid miscreant namely Mona @ Mrinal Paul, Son of Late Gour Gopal Paul and Sanjit Chakraborty, Son of Late Amal Chakraborty have painted the said iron gate and mentioned “**Legal heirs of Tukra Singh**”. The said miscreants are desperate to dispossess us from our land and take possession of our

land by hook or crook. Further the said persons have created false documents of the same plot of land and also of the adjoining plots. The men and agents of Mona @ Mrinal Paul have already grabbed a few lands using their muscle power and are continuously trying to grab our land too using all possible means.


We therefore request you to enquire in the said matter and kindly take strict action against the aforesaid culprit/s and book them under the appropriate provisions of Criminal law.
