I, Sri Hillol Kumar Das, Son of Kshitish Chandra Das, at present residing at Flat No.343, Block – 3, 4C, Green Valley Apartment, behind Vishal Cinema Hall, Post Office- Sevoke Road, Police Station- Bhaktinagar, District- Jalpaiguri, PIN-734001 would like to inform you that I along with my wife Smt Tapobrata Das are the joint owners of a piece and parcel of vacant land measuring 6 (Six) Kathas and 10 (Ten) Chattaks appertaining to and forming part of Plot Nos. 96 (part) comprised in L.R. Plot Nos.566 corresponding to L.R. Khatian Nos.520 and 521 situated within Mouza – Dabgram, Sheet No.2 (LR), J.L. No. 2, Pargana – Baikunthapur, located within Kanchanjunga Complex, near Northern Flour Mill, under Ward No.42 of Siliguri Municipal Corporation, Police Station – Bhaktinagar, District – Jalpaiguri.
