Respected Sir,

With due respect, I beg to state as follows:

1) That I along with my wife and my other relatives namely Binod Bajla and Ramesh Bajla are absolute owners of total land measuring 3.15 acres, being L.R. Plot Nos. 525, 526, 527, 528, 530 & 531, recorded in Khatain No. 487, 488, 489 & 490, under Mouza Dumriguri, P.S. Bagdogra, Dist. Darjeeling by virtue of registered deed of sales being No. 3264 for the year of 2004, 994 for the year of 2004, 10164 for the year of 2011, 717 for the year of 2012, 2508 for the year of 2012 and 10473 for the year of 2012 and we have covered the said land by constructing boundary walls.

2) That on 06.10.2014, I have found that some persons have put some signboards at the front of the said land containing the names of Md. Islam, Sharmila Khatun, Noorjahan, Hazera, Fajluddin Md. @ Md. Fazlu, Md. Saiful Islam, Alimon Khatun, Md. Maghu Rahaman, Abdul Kadir and one Sri Naba Kumar Dey and finding no other alternative, I have filed a suit against the above named persons in the Court of Ld. Civil Judge, Junior Division at Siliguri being Title Suit No. 18/2015 and my other relatives also filed suits against them being Title Suit No. 19/2015, 20/2015 and 21/2015 and the Ld. Civil Judge, Junior Division at Siliguri was pleased to pass an order on 16.06.2015 directing to maintain status-quo and the said suits are pending.

- 3) That subsequently, said Naba Kumar Dey, Son of Hemendra Chandra Dey, Raja Dey along with said Md. Saiful Islam made attempts on several occasions to capture our land forcibly and they have also made some structures on some portion of our land most illegally by violating the order of status-quo and they have also assaulted me and my relatives on 01.09.2017 and for which, I have lodged a written complaint to you on 01.09.2017.
- 4) That inspite of order of status-quo passed in Title Suit No. 18/2015, on the some portion of the land of the said suit, construction was started by violating of the order and ultimately, I have lodged a written complaint to you on 01.04.2019 and after enquiry, I came to know that one Sri Vikash Kumar, Son of Sri Dinesh Sah of 33, Gram Chatti Road, Near Mandir Gram Chatti Road, P.O., P.S. & Dist. Begusarai-851101 (Bihar) and Smt. Jhuma Roy, Wife of Sri Raju Roy of Bhujiapani Jote, P.O. & P.S. Bagdogra, Dist. Darjeeling-734014 (W.B.) and their men and persons started the construction work on the portion of the said land and I also came to know that Md. Fazlu Rahman, Son of Late Sirajuddin Rahman, Md. Aliyur Rahman, Son of Late Sirajuddin Rahman, Md. Motiur Rahman, Son of Late Sirajuddin Rahman and Md. Mujibor Rahman, Son of Late Sirajuddin Rahman sold and transferred land measuring 5 Kathas mentioning L.R. Plot No. 530 corresponding to R.S. Plot No. 867 through their constituted attorney Sri Laxman Sharma, Son of Sri Thakur Prasad Sharma of Milan More, Champasari, P.O. Champasari, P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling by executing a Deed of Sale being No. 6669 for the year of 2010.
- 5) That I also came to know that one Smt. Muni Devi (Guragain), Wife of Narayan Guragain of Vill. - Mandir, P.O. Kanglatongbi, P.S. Sekmai, Dist. Imphal-795151 (Manipur) sold and transferred 5 Kathas land to said

Vikash Kumar and Jhuma Roy by virtue of a registered deed of sale being no. 4622 for the year of 2017 and 4678 for the year of 2017.


- 6) That thereafter, I have filed a suit against them in the Court of Ld. Civil Judge, Junior Division at Siliguri being Title Suit No. 78/2019 and Ld. Court was pleased to pass an order on 09.04.2019 directing to maintain status quo in respect of the nature, character and possession of the land.
- 7) That inspite of order of status-quo, the above named persons have made some illegal construction and different litigations are pending in different Courts against the above named persons.
- 8) , That on 14.05.2022, I went to the above mentioned land for looking after the same and I noticed that said **Sri Raja Dey, Sri Naba Kumar Dey**, - both are Sons of Hemendra Chandra Dey of Mulaijote, Gossainpur, P.O. & P.S. Bagdogra, Dist. Darjeeling and **Md. Saiful Islam**, S/O Fajluddin Md. @ Md. Fazlu of Loknath Nagar, Air Port More, P.O. & P.S. Bagdogra, Dist. Darjeeling started to gather there and after expiry of some times, the above named persons and some miscreants wrongfully restrained and confined me and they claimed Two Crore rupees from me and they have also threatened me that if I will not pay the said amount to them, they will not allow me and my other relatives to enjoy our land but they will capture our land forcibly and they have also threatened me that if I will lodge any complaint against them, they will murder me.
- 9) That from the behaviour and conducts of the above named persons, it appears to me that the above named persons are members of the same racket and they are land mafias and there are big conspiracy amongst each others and they have made a conspiracy to extort money from me by putting me in fear of death and also by taking possession of our land forcibly.

- 10) That the deeds which were executed in favour of said Vikash Kumar and Jhuma Roy are forged documents but by using the said forged documents, the above named persons are trying to compel us to fulfill their unlawful demands.

So, we therefore, request you to investigate the matter after starting a specific case against the above named persons and to take appropriate action against the above named persons so that the above named persons be punished according to law. And for this kindness, I shall much oblige to you.
