Kiran Debi Singh w/o Sri Satob Singh (4) Smt. Kajal Singh w/o Sri Rajib Singh, all are resident of 2 No. Jyoti Nagar colony, Ward No. 4 SMC, P.O-Siliguri Bazar, P.S-Siliguri, Distt. Dajeling, demanded to bring money to buy a pick up van for my husband, from my parental's house, since my parents are poor and not in a position to give them dowry, I denied to do that, then they all started beating me with fist and blows & evicted from my matrimonial house, saying that when I will bring the said amount then they will allow me to enter into the my matrimonial house, then I left from there along with my 02 (two) female child and presently staying at the house of my mother namely Smt. Laxmi Saha, at 2 No. Jyoti Nagar Colony, Ward No. 4 SMC, P.O-Siliguri Bazar, P.S-Siliguri Distt. Dajeling.

Sir, it is pertinent to say that nearly 11 (eleven) years back, my marriage was solemnized with said Mukesh Singh under Hindu rites & rituals and since after my marriage, my said husband & his said relatives, are subjecting me for physical and mental cruelty, for demand of dowry.

So, please take necessary action against my husband and his above named relatives.
