With due respect, I, **SRI GOUR MANDAL**, S/O Late Kalipada Mandal, residing of Hakim Para, Rash Behari Sarani, Ward No 17 of S.M.C., P.O & P.S. Siliguri, Dist- Darjeeling, would like to lodge this Written Complaint that one Mr. Rasid Miah, Son of Abdul Ajij Miah of Rabindra Nagar Siliguri was/is the registered owner of one Toto E-Rickshaw Vehicle vide Regn. No. **WB 73 F / 2409** and in the year of 2019, I have purchased the aforesaid vehicle Being Regn. No WB 73 F/ 2409 from the registered owner Mr. Rasid Miah and a Deed of Agreement of Sale was executed on 07.11.2019 in between myself and said Mr. Rasid Miah but due to some restriction in the department of the A.R.T.O., the vehicle could not be registered in my name but since the date on 07.11.2019, the aforesaid vehicle was in my custody and I have been plying the said vehicle for my livelihood as well as for my family members and this is my only source of income. Today, in the morning at about 11:30 AM, after collecting Ration goods from the M.R. dealer, I have placed my vehicle in front of our house and after delivery all the Ration goods to my wife, when I again came out from the house, I noticed and found that my vehicle was not there where I have parked my aforesaid vehicle under lock and key and thereafter myself and my family members have started to move here and there to find out and locate my aforesaid vehicle but could not trace out my said vehicle. It is my strong believe that some unknown miscreants have stolen and theft my aforesaid vehicle and have concealed and kept my said vehicle to some unknown places for their wrongful gain.

I, therefore, request you to kindly investigate the matter properly and please take necessary legal action against the miscreants who have stolen and theft my vehicle and also requested to recover my said vehicle from the hands of the miscreants as early as possible and oblige thereby.
